

Crazyfunbabe™ Privacy Policy

Crazyfunbabe™ understands the importance of privacy and is committed to protecting the privacy of your personal information. This Privacy Policy explains how Crazyfunbabe™ collects and uses your personal information.

WHY DO WE COLLECT PERSONAL INFORMATION?

Crazyfunbabe™ collects personal information to improve the manner by which we operate and offer our products and services. We use the personal information to communicate with you about those products and services, and provide effective, timely customer support when needed. We will never rent or sell any of the personal information we collect from you to anyone, and will not share your personal information with anyone without your consent except as described in this Privacy Policy.

WHAT PERSONAL INFORMATION DO WE COLLECT?

The information we gather is based upon the services that you use.

The information may include your mobile phone number; your name and email address and certain optional information such as your birth year and zip code.

- If you decide to purchase content from us, we may also ask for your billing information including your billing address.
- We collect demographic information provided by you (such as language, gender and age, and, if applicable, content preferences and personalization information).
- We will not sell, rent or otherwise distribute your personal information to third parties without your consent, except as set forth below.

HOW DO WE USE YOUR PERSONAL INFORMATION?

Crazyfunbabe™ uses your mobile phone number and mobile phone device information to deliver to you alerts, mobile phone content such as ringtones, full-track music downloads, pictures, and videos.

Crazyfunbabe™ uses your other personal information to deliver to you and bill you for Crazyfunbabe™ products and services, and communicate with you concerning your account and customer service issues.

This may include:

- verifying authorization of credit card usage before any purchase of premium content or services;
- updating you on important changes to your account such as the receipt of payments and thanks for inviting your friends.
- determining if you meet the minimum system requirements to use our products, and providing information concerning compatibility and interoperability to you;
- asking you to participate in surveys about products, services, news and events;
- offering you product upgrades, content and services for you to purchase;
- providing you with content, services, instructions, and a more personalized experience based on personal information, such as zip/postal code and any content or other preferences you provide;
- providing you with news, free newsletters, updates, targeted advertising, promotions, and special offers that give you a better understanding of how our products are used.

CHILDREN'S PRIVACY CONCERNS?

Crazyfunbabe does not knowingly collect or maintain personally identifiable information or non-personally-identifiable information on any Crazyfunbabe website from persons under 13 years of age, and no part of our websites is directed to persons under 13. If you are under 13 years of age, then please do not use or access the Crazyfunbabe websites or services at any time or in any manner. If Crazyfunbabe learns that personally identifiable information of persons under 13 years of age has been collected on the Crazyfunbabe website without verified parental consent, then Crazyfunbabe will take the appropriate steps to delete this information.

WHEN AND HOW DO WE SHARE YOUR INFORMATION WITH THIRD PARTIES?

Crazyfunbabe™ does not sell, rent, or share your personal information to anyone unless you consent to provide such information. Crazyfunbabe™ may disclose relevant information about our customers to our contractors (e.g. a customer service contractor or a credit card clearing service) in order for them to provide specific services for Crazyfunbabe™, and to better serve our customers. Crazyfunbabe™'s contractors are bound by strict contractual requirements to keep all personal information they process strictly confidential and to use such information solely on behalf of Crazyfunbabe™. Also, Crazyfunbabe™ may disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to:

- (a) conform to the edicts of the law or comply with legal process served on Crazyfunbabe™;
 - (b) protect and defend the rights or property of Crazyfunbabe™ and its products;
- or
- (c) act in urgent circumstances to protect the personal safety of users of Crazyfunbabe™ products or the public at large.
